Mobile Money® is a service that allows you to log into Virtual Branch (VB) from your cell phone, using either a mobile browser or a down-loadable application. You can also sign up to use texting to get your balance, history and do transfers. Once you are logged into VB, click on the SELF SERVICE tab and you will see Mobile Money. Did you know?

- The names of the signers of the Declaration of Independence were withheld from the public for more than six months to protect the signers. If independence had not been achieved, the treasonable act of the signers would have, by law, resulted in their deaths.

- Thomas McKean was the last to sign in January, 1777.
- Both Thomas Jefferson and John Adams died on Independence Day, July 4, 1826.
- In 1941, Congress declared 4th of July a federal legal holiday. It is one of the few federal holidays that have not been moved to the nearest Friday or Monday.

FREE ANNUAL CREDIT REPORT


Getting your free annual credit report is a great way to fight identity theft by monitoring and reviewing your report yearly.

You may request your free credit report three different ways:


1. Online www.annualcreditreport.com
2. By phone (1-877-322-8228)
3. By mail

Free credit reports requested online are viewable immediately upon authentication of identity. Requested reports by phone or mail will be processed within 15 days of receiving your request. You are entitled to receive one free credit report through the Central Source every 12 months from each of the nationwide consumer credit reporting companies: Equifax, Experian and TransUnion. If you order from only one company today, you can still order from the other two companies at a later date.
